- DoD INRMPs that include green sea turtles.
- Endangered Species Act Section 7(a)(1) actions.
- Five-year action plans for NOAA's Species in the Spotlight, planned for release later this fall.

These are plans highlighting specific actions that NOAA feels are needed in the next five years to slow, halt, or reverse the declining population trends for the eight spotlight species (Atlantic Salmon Gulf of Maine Distinct Population Segment (DPS), Central California Coast Coho Evolutionarily Significant Unit (ESU), Cook Inlet Beluga Whale (DPS), Hawaiian Monk Seal, Pacific Leatherback Sea Turtle, Sacramento River Winter-run Chinook (ESU), Southern Resident Killer Whale (DPS), and White Abalone).
